

There are ten annual Federal holidays on the calendar designated by the United States Government. These days cannot be used in the calculation of disclosure receipt or rescission. If a holiday's date falls on a weekend, the federally observed date occurring on a Friday or Monday will count as a business day for these purposes. Review the 2019 Rescission Calendar posted to the Resources page on the TPO Connect portal for questions related to rescission calculation.

***Note: MLS will be closed on Friday November 29, 2019 in observance of the Thanksgiving holiday weekend.**

The following should be considered:

- Friday November 29, 2019 does count as a business day towards rescission and disbursement.
- Friday November 29, 2019 does count as a business day towards LE disclosure timing. Therefore, this day can be included in counting the seven business day waiting period from when the initial LE was provided to consummation.
- Friday November 29, 2019 can be counted as a business day for the 3-day prior to closing appraisal delivery requirement
- Friday November 29, 2019 can be counted as a business day for the 3-day timing requirement for the borrowers' receipt of the Pre-Closing Disclosure.

IMPORTANT

- Since MLS will not be open on Friday November 29, 2019, no fundings will be processed on Friday November 29, 2019.
- MLS's lock desk will not be open on Friday November 29, 2019. You will not be able to price loans in Optimal Blue.
